Bob Ross called the meeting to order

Annette Bowden is asking permission to change service providers for our PBT equipment. The new contract will now be with Total Court Services which will reduce the per day rate from \$8.00 - \$5.00. This will be an open ended contract as long as we give 30 day notice to them if we decide at any point we are no longer going to use their services. This will provide the same level of supervision. Todd Meyer made motion to approve and Mike Nielson 2<sup>nd</sup> that motion. Vote, Approved.

### **ICAOS-ICOTS**

Annette and Christina will be working together for CC transfers over state lines. This would allow offenders from other states the ability to transfer the CC supervision to their home state. This will also allow offenders from other states to transfer CC here to Boone County providing certain criteria.

Monthly Financial Report- Kari had nothing new to report. February and March financials were provided. Financials were approved as presented.

## Grant Review (3/22/2016)

Michael reported Grant Review hearing will be held tomorrow with DOC and IJC. These reviews will be taking place now-April 14. We should have decisions by April  $22^{nd}$  and have received our contract by May  $2^{nd}$ . Penny, Kari, Michael and Todd will be attending.

## Levels of Supervision

Michael presented the current levels of supervision proposal after revisions had been made from the last Operations Meeting.

There will be a client advisement advising the client that a change in supervision is a privilege, not all clients will qualify.

Level 1 Punitive (first year) All sex offenders will remain in level one Public expectation, board expectation, Evidence based practice- Target Interventions Level 2 Developmental

Evidence Based Practice-Increase Positive Reinforcement

Level 3 Integration

Evidence based practice- engage ongoing support in natural communities

Levels of supervision will be retroactive. Judge Edens made motion to approve and Todd Meyer 2<sup>nd</sup>. All voted and Levels of Supervision Approved!

Michael and Annette will hold client meetings will all of the clients in June to explain the levels of supervision to reduce any confusion. This will become effective July 1, 2016.

Recently BCCC and the Boone County Sherriff collaborated together to take inmate workers from the Boone County Jail and Work Release participants and spent the day providing community service work for the Thorntown Little League. Six hours were spent cleaning, panting and preparing the field for the upcoming season. Future Community Service work is being organized at this time.

We will be reducing our Sleeptime bracelet availability to 5. We currently have 3 on ST and we have to pay for the equipment that we are not using. Annette will be working on this.

#### JDAI

Grant due at the end of the month. Day reporting is going well. JDAI will be purchasing a van. YOC has all of the licensures needed to run this van/program. It will be used to transport kids to different locations as part of JDAI.
