Dave Truitt called the meeting to order.

May 20, 2019 Minutes presented for approval. Approved.

Justin Culp was introduced. Justin is our new juvenile probation officer. Also, Steve Owens is the new Assistant Chief and has been acting in that capacity since the retirement of Donna Hankins.

Financial Report – present by Kari. Change to the fiscal year which will now run Jan 1 – Dec 31 which is a change from the previous July 1- Jun 30. Projected project income at fiscal year end was at 114%. Fee collection is up and things are going well with that.

JDAI - Nothing new to report with JDAI. Judge Schein will be attending a training in Seattle in the upcoming months.

Felony Diversion prevented by Sam – approximately 60 on Felony Diversion now. High success rate. Sam estimated approximately 5 or less “failures” in three years since the program has been running.

HD Numbers presented by Jana – as of 8/19/19 there are 72 active clients on BCCC GPS/ HD. Of those clients, 1 is being monitored pretrial and there are 14 clients set to be released by the next AB meeting in October.

49 prescreen requests received since 5/20/19 and 29 have met eligibility requirements and have been recommended for placement on HD/GPS.

One year ago on 8/20/18 there were 60 adult clients on BCCC HD.

Pretrial presented by Ashley. There are currently 81 clients on pretrial supervision. Mock assessments will begin in September. Pretrial summit is scheduled for Oct 4th and members of the steering committee will be in attendance.

Set a record for project income collected (\$446,925.83). No requests for County General Funds.

Continued development on pretrial program (launch January 2020).
