ORDINANCE 2019-12

BOONE COUNTY BOARD OF COMMISSIONERS

AN ORDINANCE AMENDING BOONE COUNTY CODE SECTION 70.05 RELATING TO OFF-ROAD VEHICLES ON COUNTY OWNED RIGHT-OF-WAY

**WHEREAS**, The Board of Commissioners of Boone County, Indiana (“Boone County”), may, pursuant to Indiana law [I.C. 36-1-3 (Home Rule)], enact ordinances for effective governance of the County and its Offices and Departments; and

**WHEREAS**, Boone County is responsible for maintaining all county owned roads within its jurisdiction and may regulate the operation of certain vehicles on rights-of-way to provide for the safety of pedestrians and motorists using county roads; and

**WHEREAS**, Boone County previously adopted Ordinance 2015-05, relating to the operation and registration of Off-Road Vehicles, which such Ordinance was codified as Section 70.05 in the Boone County Code of Ordinances; and

**WHEREAS**, Boone County finds that is in the best interests of the County, its residents and taxpayers to allow for off-road vehicle registrations to be issued for up to three (3) years.

**NOW, THEREFORE, BE IT ADOPTED AND ORDAINED** by the Board of Commissioners of Boone County, State of Indiana, to hereby amend Boone County Code Section 70.05 as follows (*bold italics denote added language*; language stricken is denoted with lines through the text):

...

(D) The Off-Road Vehicles must be annually registered with the Boone County Highway Department (“BCHD”). The fee for annual registration shall be Twenty-Five Dollars (\$25.00). *The registration may be issued for up to three (3) years for a fee of Seventy-Five Dollars (\$75.00).* The registration sticker shall be visibly displayed on the vehicle. Registration shall occur on January 1 of each year. All registration fees received by the BCHD shall be deposited in a non-reverting fund for use by the BCHD for road maintenance.




