The Harrison monument at Corner 1 was set over a stone found.

A BCS record dated March 28-29, 1907 states, with respect to Corner 1, "Reestablished by locating 'A' sec. 30 R 1 W, and measuring lap. Set 2 rocks. Lower one 4-5-6 +. Top one 6-8-10 +." This statement is interpreted to indicate that the location of Corner 2 (Cor. A, sec. 30) was known and that Corner 1 (SE corner section 24 & NE corner section 25, R2W) was established at the record federal offset from the known corner. It is noted that the closing offset at this corner is 96 links south, equating to 63.36 feet. No modern BCS tie cards were found referencing this corner.

Excavation was performed at Corner 1 on April 13, 2016. Prior to excavation, a 5/8 inch diameter rebar with no cap was found ostensibly marking Corner 1 (sections 24 & 25) and a 5/8 inch diameter rebar with a yellow cap was found in the general vicinity of Corner 2 (sections 19 & 30), 59.2 feet south of the uncapped rebar. The source of these monuments is not known. Analysis of the relative positions the approximate centers of County Road 800 North to the east and west of the intersection, with respect to the closing distance of 96 links, indicated that the original positions of the corners were likely further north than the respective positions of the found monuments.

Excavation was performed exclusively at Corner 1, as Corner 2 falls at the edge of an existing drainage ditch on the south side of County Road 800 North. Excavation at Corner 1 revealed two stones found approximately 8 feet north and 5 feet east of the existing rebar ostensibly marking Corner 1. The top stone was found at 14 inches deep. The stone was found to be approximately 11 inches N-S by 8 inches E-W by 5 inches tall with a distinct "+" mark etched on the top. The stone was removed and another stone was found below. The lower stone measured approximately 7 inches N-S by 6 inches E-W. This stone also had a distinct "+" mark etched on the top. The height of the lower stone was not measured, as it was left in place, generally undisturbed at 20 inches deep. The two stones were found to match the record dimensions stated in the 1907 record within reasonable tolerance. With the similar measurements and the distinct, etched marks on both rocks, they were accepted being the monuments described in the 1907 record and were held as marking the corner. It is noted that these rocks were found to be significantly closer to the position for the corner as estimated prior to excavation than was the found rebar. The top stone was removed and the lower stone was left in place, undisturbed. A Harrison monument was set directly over the mark on the lower stone. Three rebars of 3/8 inch diameter by 20 inches in length were driven at slightly off vertical around the lower stone to provide for stability of the concrete base in which the Harrison monument was set. The precise position of the corner is 8.3 feet north and 5.1 feet east of the rebar found prior to, and removed during, excavation. This document was originally published on February 20, 2017 showing only the position of Corner 1 and stating that the position of Corner 2 would be determined after the adjacent corners to the north and south are established.

Having perpetuated the positions of the Corners to the north and south, Corner 2 was established in April, 2019. Per the original federal notes and the BCS record of 1907, Corner 2 was established at 96 links, or 63.36 feet, south of Corner 1, along the range line as defined by the corners to the south (see BCS Corners NW 700-600 and NW 750-600).

It is noted that a survey by Cary B. Dodge, LS #S0288, recorded in Survey Book 1, pages 11-12 and a survey by Jerry L. Carter, LS #S0350, recorded in Survey Book 11, page 64, both in the Recorder's Office of Boone County, show both corners as being 5/8 inch rebars. The rebar shown as being Corner 1 is believed to be the same rebar as discussed above, found to be 8 feet south and 5 feet west of the stone set in 1907. Notably, the Dodge and Carter surveys show Corner 2 to be at 54 feet south of Corner 1, rather than 63.36 feet. Hence, holding the stone set in 1907 and holding the record closing distance, the position of Corner 2 is believed to be within approximately one foot north-south of the position held by Dodge and Carter, but approximately 5 feet east. The rebar shown on the two surveys was not found. The rebar with yellow cap found near Corner 2 was left in place, 5.2 feet west and 4.4 feet south of the Harrison monument set at Corner 2. This is not believed to be the same monument as shown on the Dodge and Carter Surveys.

Corner 1 was originally established as a wood post in 1819. Corner 2 was originally established as a wood post in 1829.


The Harrison monument was set in place of a rebar found.

A BCS record of November 28, 1885 states, with respect to this corner, "Found from stump of Lynn and B. Walnut, ...., rock 15.12.12."

No recent BCS tie cards were found referencing this corner. A survey recorded in Survey Book 13, pages 73-74 in the Office of the Boone County Recorder shows this corner as a 5/8 inch diameter rebar with plastic cap stamped "Dodge S-0288." The survey states that the rebar was set by Cary Dodge, LS S0288, by survey dated April 3, 1998.

This corner was excavated on December 3 and December 17, 2018. Prior to excavation, the rebar called on the aformentioned survey was found flush with the adjacent ground, situated in an east-west fence. Minor excavation and substantial probing around the rebar and along the base of the fence in both directions revealed no further evidence of the corner. No rocks of any substantial size were found by probing. It is observed that the rebar fits well with evidence of the section line, being in the east-west fence and being generally in-line with the center of the county road to the east. It is also observed that the rebar fits well with the relative positions of the corner 1/2 mile east (see BCS corner NW 800-600) and evidence of the 1/4 1/4 corner between the subject corner and said corner NW 800-600. A railroad spike found in the center of County Road 800 North, situated directly south of an old wood post on the north side of the road is within one foot, east-west, of a theoretical midpoint between the found rebar at the subject corner and the corner 1/2 mile east. Hence, it is observed that the found rebar fits well with the local evidence (fence and road) in the north-south dimension and fits well with approximately one foot of uncertainty with the remote evidece (corners 1/4 mile and 1/2 mile east, respectively) in the east-west dimension. 




The harrison monument was set over a vertical section of railroad rail found. No specific descriptions of this corner were found in the BCS Surveyor's Record beyond the original establishment of the corner as a wood post in 1829. The corner is shown on records of 1832, but not described. It is shown as the terminal point for measurements on records of 1889 and 1907. A BCS tie card dated October 2, 1964 states 'pile 3" x 5" stones found. RRR set.'

This corner was excavated on March 29, 2011 in response to questions about GIS parcel mapping in the vicinity. Prior to excavation a PK nail was found at the edge of County Road 700 West, in line with the southerly prolongation of the center of the road to the north and in line with the westerly prolongation of a fence to the west. The nail was removed and a rebar with a plastic cap stamped "Witness Point" was found below. The rebar was bent. The rebar was removed and a vertical section of railroad rail was found and 16 inches deep. The position of the rail was slightly northeast of the nail. The rail was accepted as being the monument called for on the 1964 tie card, set in place of the 'pile of stones.'

The deeds for several parcels in this immediate vicinity call for the east-west section line to be along the approximate north right-of-way of County Road 800 North and call for the north-south section line to the south of the corner as being along the approximate west right-of-way line of County Road 700 West. The position of the rail fit with this description and also fit with occupation and monumentation, relative to deed ties to the corner, for properties to the north and south of the corner.

The railroad rail was held as marking the corner and was left in place. The harrison monument was set directly over the rail.





The stone was found in place. The 5/8 inch diameter rebar with 'Boone County Surveyor' cap is is intended as a witmess to the stone, set along the north edge, 0.5 foot north of the top, high point of the stone.

A BCS Record dated April 22, 1913 states, with respect to this corrner, "Found Rock at true point (not recorded)." The record shows distances to the corners 1/4 and 1/2 miles east and west, respectively. The distances shown are not equal, being 20 chains and 20 chains to the west and 19.79 and 19.79 chains to the east.

This corner was excavated on November 8, 2018. Prior to excavation, no specific survey monuments were found in the vicinity of the corner. A survey by Jerry L. Carter, LS S0350, recorded in Survey Book 5, page 47 in the Office of the Boone County Recorder shows the corner as a steel post. An approximate position for the corner was computed with respect to the Carter survey and with respect to the monumented center of section 13 (see BCS Corner NW 950-650) and a wood corner post found approximately 1/4 mile north of the subject corner, said post being the corner post for fences to the north and east. Excavation in the vicinity of the computed position revealed evidence of an east-west fence, mostly removed but with numerous scraps of wire left in the ground, in an east-west grass strip. Numerous small stones were found in the immediate vicinity of the corner. One larger stone was found which bears the characteristics of a stone purposely set to mark the corner. The top of the stone was found at 6 inches deep. The stone is 15 inches tall by 14 inches N-S by 12 inches E-W. A fallen down steel t-post was found along the west edge of the stone and fragments of an old wood post were found along the east edge of the stone. The north, east and west sides of the stone are flat and vertical while the south side slopes. The stone falls approximately 1.5 feet west of a line extended from a post on the southerly edge of County Road 950 North, immediately south of and approximately 1 foot east of the center of section 13, through the aforementioned corner post approximately 1/4 mile north of the subject corner. 

Carter, LS S0350, recorded as document 0303136 in the Office of the Boone County Surveyor, shows the corner as a head post and shows a rebar with cap 26.87 feet to the west.

This corner was excavated on November 7, 2018. Prior to excavation, the post and rebar called in the Carter survey were found as shown on the survey. Excavation in the vicinity of the post revealed numerous rocks and a variety of rubble, including broken pieces of concrete. One notable stone was found at 17 inches deep, below most of the rubble. The top of the stone measured 18 inches E-W by 9 inches N-S. The height of the stone was not measured. The center of the top of the stone was 16 inches south of the post. The stone does not match the dimensions called in 1873 record and did not appear to be a stone purposely set to mark the corner. The stone was not accepted as marking the corner. The post fits well with the relative positions of other proximate corners and falls in line with a fence to the east and the edge of a wood line to the south. The Carter survey shows the post to be in line with a fence to the south. The fence has evidently been removed since the survey was made, but the post and approximate wood line fall generally in line with the prolongation of the center of County Road 700 West, beginning approximatley 1/4 mile south of the corner. The Carter survey also shows the post in line with a N-S fence beginning 495 feet north of the corner. The post was accepted as providing the best available evidence of the corner. The post was broken at ground level but standing as supported by the fencing to the east and west. The top portion of the post was pushed toward the north and stablized by a 5/8 inch rebar driven along the south edge of the post, as shifted to the north. The portion of the post remaining in the ground was found to be mostly rotten. This portion was removed and a replaced with a Harrison monument. It is noted that the monument is situated in the precise position of the center of the post, as originally found, and that the remaining portion of the post, suspended amongst the fencing, is north of its original position. It is also noted that a fence bearing north from the rebar found 26.87 feet west of the corner does not fall along the section line. This is clearly demonstrated on the Carter survey. The land descriptions for numerous properties to the northwest, northeast and southeast contain similar language to the description contained in the Carter sruvey and appear to hold the post as the corner. Hence the presence of the north-south fence west of the section line is not considered an uncertainy. This corner was originally established as a wood post in 1829
