

ORDINANCE 2022-05

BOARD OF COMMISSIONERS OF BOONE COUNTY, INDIANA

AMENDED ORDINANCE ESTABLISHING FEE SCHEDULES FOR SERVICES PROVIDED BY THE BOONE COUNTY HEALTH DEPARTMENT

WHEREAS, Boone County, Indiana, acting through the Boone County Board of Commissioners, on May 9, 2005, adopted Ordinance 2005-12 entitled Ordinance Establishing Fee Schedules for Services and Records Provided by the Boone County Health Department ("Health Department") and on August 20, 2007, adopted Ordinance 2007-18 amending Ordinance 2005-1; and on January 18, 2011 adopted Ordinance 2011-02 amending Ordinance 2007-18; and on April 4, 2011, adopted Ordinance 2011-04 amending Ordinance 2011-02; and on December 5, 2011 adopted Ordinance 2011-10 amending Ordinance 2011-04; and on November 19, 2012 adopted Ordinance 2012-08 amending Ordinance 2011-04; and on October 17, 2016 adopted Ordinance 2016-04 amending Ordinance 2012-08; and

WHEREAS, since the adoption of Ordinance 2005-12, 2007-18, 2011-02, 2011-04, 2011-10, 2012-08 and 2016-04, the costs for services provided by the Health Department have increased and modifications have been deemed necessary and approved by the Health Department Board; and

WHEREAS, Boone County, Indiana, now desires to amend the aforementioned Ordinances to provide for a revised fee scheduled to reflect the increased costs of providing the services by the Health Department to include a \$50 plan review fee for Mobile Food Establishments. The revised fee schedule is attached hereto as Exhibit A; and

WHEREAS, the Boone County Commissioners desire to ratify, affirm and continue in full force and affect Ordinance 2005-12 enacted by them on May 9, 2005, Ordinance 2007-18 enacted by them on August 20, 2007, and Ordinance 2011-02 adopted January 18, 2011, Ordinance 2011-04 adopted April 4, 2011, Ordinance 2011-10 adopted December 5, 2011; Ordinance 2012-08 adopted November 19, 2012, and Ordinance 2016-04 adopted October 17, 2016 except as amended herein.


NOW THEREFORE, BE IT NOW ORDAINED by the Board of Commissioners of Boone County, Indiana, as follows:


